(Milan: AGL IM) announces that in period from 10 October to 14 October 2011 the Company purchased a total of no. 200,000 own shares at the average net price of 7.974 euro per share, for a total value of 1,594,800.00 euro, within the authorization resolved upon by the Shareholders' Meeting on 21 April 2011 (already announced to the market also in compliance to art. 144 bis of Consob Rule n. 11971/1999).
