

## Filing of annual financial report and documents for the Annual General Shareholders' Meeting

Milan, 12 April 2019 – With reference to the Autogrill S.p.A. (Milan: AGL IM) General Shareholders' Meeting, scheduled for 23 May 2019 in a single call at 10.30 am (ordinary session) at 16, Corso di Porta Vittoria (Centro Congressi), Milan, the following documents are available to Shareholders and the public on the Company's website (www.autogrill.com, governance section – Shareholders' meeting), on the central storage mechanism named 1Info (www.linfo.it) and at the Company's registered office and secondary headquarters:

- (iv) the Board of Directors' report on the items on the agenda pursuant to art. 125-ter, FSA, along with the full text of the proposed resolutions.
